## **Data Protection**

In case of accessing the general information of the Thoraxklinik, information about user access will exclusively be stored in anonymous form in the log files. Only the fact of accessing and the document accessed will be stored. A reference to the identity of the user is in all cases excluded. No single user profile will be created, also not in pseudonym form.

## **Third Parties**
